

**Bay FC Egg Hunt Giveaways**  
**Official Rules**

**Important: Please read these Official Rules before entering the Bay FC Egg Hunt Giveaways (the “Sweepstakes”). THESE OFFICIAL RULES CONTAIN AN ARBITRATION PROVISION WITH A CLASS ACTION AND JURY TRIAL WAIVER. THE ARBITRATION PROVISION MAY HAVE A SUBSTANTIAL IMPACT ON THE WAY IN WHICH YOU OR BAY FC RESOLVE ANY DISPUTE OR CLAIM ARISING FROM OR RELATED TO THE SWEEPSTAKES AND/OR THESE OFFICIAL RULES.**

1. **GENERAL.** NO PURCHASE NECESSARY TO ENTER TO ENTER OR CLAIM A PRIZE. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. By submitting an entry to the Sweepstakes, the Entrant (as that term is defined below) acknowledges and agrees to these Official Rules. The Sweepstakes is void where prohibited by law. By entering the Sweepstakes, Entrants agree to be bound by these Official Rules and by all decisions of Bay FC (as that term is defined below), whose decisions are at its sole discretion and are binding and final in all respects. Failure to comply with these Official Rules will result in disqualification from the Sweepstakes.
2. **ELIGIBILITY.** The Sweepstakes is open only to legal United States residents who are physically located in the fifty (50) states of the United States of America or the District of Columbia and who are eighteen (18) years of age or older and the age of majority in their state of residence as of the beginning of the Sweepstakes Period. Employees of (i) BAFC Holdings, LLC and/or BAFC Team Operator, LLC (collectively, “**Bay FC**”), (ii) National Women’s Soccer League, LLC and each of its member clubs (collectively, “**NWSL**”), and (iii) each of their respective parent companies, subsidiaries, affiliates, officers, directors, agents, employees, advertising and promotion agencies, licensees, distributors, dealers, retailers, printers, and representatives (collectively, the “**Organizing Entities**”), and members of their immediate families (spouses, parents, children, and siblings and their spouses) and/or household members (whether or not related) of each of the foregoing are not eligible. The Sweepstakes is void where prohibited or restricted by law. IF YOU DO NOT MEET ALL OF THESE REQUIREMENTS OR ANY OTHER ELIGIBILITY REQUIREMENTS IN THESE OFFICIAL RULES, YOU ARE NOT ELIGIBLE TO WIN A PRIZE.
3. **TIMING.** The Sweepstakes begins on Sunday April 5, 2026 at 12:00 p.m. PT and ends on Sunday April 5, 2026 at 4:30 p.m. PT (“**Sweepstakes Period**”). All times in the Sweepstakes refer to Pacific Time.
4. **HOW TO ENTER.** No purchase necessary. To enter, locate a Bay FC easter egg hidden in and around PayPal Park (including in parking lots adjacent to PayPal Park) during the Sweepstakes Period and redeem your Prize (as that term is defined below) by following the instructions listed on the paper inside the egg. Successful completion of the foregoing shall be considered an “**Entry**” and the person submitting the Entry, the “**Entrant.**” As a condition of entering the Sweepstakes, each Entrant gives consent for Bay FC to obtain and deliver their name, address and other identifying information to third parties for the purpose of administering the Sweepstakes and to comply with applicable laws,

regulations, and rules. Any information Entrant provides to Bay FC may be used to communicate with Entrant in relation to this Sweepstakes or on a Sweepstakes winner's list.

5. **CONSENT TO RECEIVE MARKETING MESSAGES.** As a condition to entering the Sweepstakes, each Entrant consents to the processing of their name, e-mail, and/or phone number by the Organizing Entities and their service providers in accordance with Bay FC's Privacy Policy located at <https://bayfc.com/privacy-policy/>. Each Entrant consents to receive e-mails, calls, and/or text messages, including live, prerecorded, and/or automated calls and messages, to that email or phone number. Entrants may opt-out of receiving such e-mails, calls, and/or text messages at any time upon notice to the Organizing Entities.
6. **LIMIT ONE (1) VALID ENTRY PER PERSON.** Any attempt by any Entrant to obtain more than the stated number of Entries by using multiple/different email addresses, accounts, identities, registrations and logins, or any other methods will void that Entrant's Entry and that Entrant may be disqualified. Use of any automated system to participate is prohibited and will result in disqualification. In the event of a dispute as to the identity of any Entrant, the authorized account holder of the email address used to enter will be deemed to be the Entrant and he/she must comply with these Official Rules. The "**authorized account holder**" is the natural person assigned an email address by an Internet access provider, online service provider, or other organization responsible for assigning email addresses for the domain associated with the submitted address. The potential Winner may be required to show proof of being the authorized account holder.
7. **SELECTION OF WINNER.** Fifty (50) winners will be selected by locating an egg in or around PayPal Park during the Sweepstakes Period (each a "**Winner**"). Each Winner will receive the Prize (as that term is defined below) described in the paper located inside the easter egg. Winners may be required to sign and return to Bay FC an affidavit of eligibility and liability and publicity release within 48 hours of receipt. If (i) any Prize notification is undeliverable, (ii) a potential Winner does not respond to notification in a timely manner, or (iii) in the event of non-compliance with any of these requirements, then the Prize(s) will be forfeited, and alternate Winner(s) will be selected from the remaining eligible Entries. The odds of winning depend on the number of eligible Entries received within the Sweepstakes Period. In the event of early termination, Bay FC reserves the right to award the prize(s) in a random drawing from among all eligible entries received prior to such termination.
8. **PRIZES.** A total of fifty (50) prizes will be awarded for the Sweepstakes. The Prizes will consist of:
  - (a) One (1) signed Ottawa Rapid FC jersey and two (2) tickets to Bay FC's April 17, 2026 Spring Series match against Ottawa Rapid FC (a total of one (1) Prize to be awarded);
    - a. Estimated value of one hundred seventy dollars (\$170);
  - (b) A thirty-dollar (\$30) food and beverage voucher redeemable at the April 5, 2026 Bay FC match only (a total of eight (8) Prizes to be awarded);
    - a. Estimated value of thirty dollars (\$30);

- (c) Two (2) tickets to attend Bay FC's open practice (date to be confirmed) (a total of five (5) Prizes to be awarded);
  - a. Estimated value of fifty dollars (\$50);
- (d) A Fifty-dollar (\$50) Visa Gift Card (a total of six (6) Prizes to be awarded);
  - a. Estimated value of fifty dollars (\$50);
- (e) A Bay FC tote bag containing select Trader Joe's snacks (a total of five (5) Prizes to be awarded);
  - a. Estimated value of thirty-five dollars (\$35);
- (f) Two (2) tickets to attend an upcoming Bay FC home match during the 2026 NWSL season and the opportunity to watch warm-ups from the field (a total of five (5) Prizes to be awarded);
  - a. Estimated value of sixty dollars (\$60);
- (g) A select piece of Bay FC merchandise signed by a Bay FC player (a total of eight (8) Prizes to be awarded);
  - a. Estimated value of one hundred ten dollars (\$110);
- (h) A twenty-five-dollar (\$25) gift card to the Hello Kitty Café (a total of four (4) Prizes to be awarded);
  - a. Estimated value of twenty-five dollars (\$25);
- (i) A fifty-dollar (\$50) Bay FC merchandise discount, redeemable at the April 5, 2026 match only (a total of seven (7) Prizes to be awarded); and
  - a. Estimated value of fifty dollars (\$50);
- (j) A post-match field experience for the Winner and three (3) guests at the conclusion of the April 5, 2026 match only (a total of one (1) Prize to be awarded);
  - a. Estimated value of two hundred dollars (\$200)

(each a "**Prize**" and collectively the "**Prizes**"). The estimated value of each Prize is as listed above; this is an estimated value only. Winners will redeem the Prizes by following the instructions printed on the paper located inside of the found egg. Each Winner will be solely responsible for all federal, state and/or local taxes, and for any other fees or costs associated with the Prize he or she receives, regardless of whether the Prize, in whole or in part, is used. The Prize cannot be exchanged for cash and the Winner may not substitute the Prize. Transfer of a Prize to another individual or entity is prohibited. Limit of one (1) Prize per person. The details and availability of the Prize are subject to change in Bay FC's sole discretion and Bay FC reserves the right to substitute a similar prize of equal or greater value in its sole discretion. Sponsor will issue an IRS Form 1099-MISC to any winner receiving a prize valued at \$600 or more.

- 9. **ODDS.** Odds of winning will depend on the total number of entries received and Bay FC makes no representations or warranties regarding the probability of an Entrant winning a Prize.
- 10. **BACKGROUND INVESTIGATION.** The Organizing Entities reserve the right to conduct a background investigation on the potential Winner, and reserve the right in their sole discretion to

disqualify any potential Winner or guest based on the results of such background investigation, if Bay FC determines in its sole discretion that awarding a Prize to such winner or guest might reflect negatively on the Organizing Entities.

Potential Winner agrees and understands that he or she must agree to authorize and cooperate with an independent background investigation by Bay FC and/or its agents, if requested, by completing a consent form in the designated timeframe for an investigation of their background, references, character, employment, education, social media, and without limitation civil and criminal court records or police records, including a review of social media, including those maintained by both public and private organizations and all public records, for the purpose of confirming information provided by the potential winner and/or obtaining other information that may be relevant to qualifications as the potential Prize recipient in the Sweepstakes. Potential Winner agrees and understands that, based on such results, they may be disqualified if the results are not acceptable to Bay FC at Bay FC's sole discretion and that the specific reason(s) for any such disqualification will not be provided to any disqualified potential winner or guest.

11. **WAIVER; DISCLAIMER; INDEMNIFICATION.** By entering the Sweepstakes, each Entrant agrees to (a) be bound by these Official Rules, including all Entry requirements, and (b) waive any and all claims against Organizing Entities for any injury, damage, or loss that may occur, directly or indirectly, in whole or in part, from participation in the Sweepstakes, receipt or use of the Prize (or any portion thereof), or any travel or activity related thereto. By entering the Sweepstakes, Entrants assume all liability for any personal injury or damages caused or claimed to be caused by, arising out of or in connection with his or her participation in the Sweepstakes and/or the acceptance and/or use of any of the Prize, and agrees to indemnify, hold harmless and release each of the Organizing Entities, Instagram, Facebook, X and Tik Tok, or other comparable social media platforms, from any and all such liability. For New Jersey residents, the limitations set forth above may be inapplicable where attorneys' fees, court costs, or other damages are mandated by statute. These Official Rules shall be governed by and construed and interpreted in

accordance with the laws of the State of California, U.S.A, applicable to contracts entered into and performed exclusively in that State, without reference to California's choice of law rules.
