

Bay FC Insider Giveaway
Official Rules

1. GENERAL: **NO PURCHASE NECESSARY TO ENTER OR CLAIM A PRIZE. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING.** By submitting an entry to this Bay FC Insider Giveaway (“Sweepstakes”), sponsored by Bay FC, BAFC Team Operator, LLC and BAFC Holdings, LLC (collectively, “Bay FC”), the entrant acknowledges and agrees to all of these Official Rules. Void where prohibited. The Sweepstakes begins on Monday, January 13, 2025 at 12:01 a.m. and ends Sunday, January 19, 2025 at 11:59 p.m. (“Sweepstakes Period”). All times in this Sweepstakes refer to Pacific Time. By entering the Sweepstakes, entrants agree to be bound by these Official Rules and by all decisions of Bay FC whose decisions are at its sole discretion and are binding and final in all respects. Failure to comply with these rules will result in disqualification from this Sweepstakes.

2. ELIGIBILITY: The sweepstakes is open only to legal U.S. residents and physically located in the fifty states of the United States of America or the District of Columbia and who are 18 years of age or older as of January 1, 2025. Bay FC, the National Women’s Soccer League and its member clubs, and their respective parent companies, subsidiaries, and affiliates, and the officers, directors, agents, employees, advertising and promotion agencies and members of their immediate families (spouses, parents, children, and siblings and their spouses) and/or household members (whether nor not related) of each of the foregoing (collectively, the “Sweepstakes Entities”) are not eligible.

3. HOW TO ENTER: No purchase necessary. Go to <https://bayfc.com/join-the-team/> or click the link on the Bay FC website, application or advertisement. To be eligible, each Sweepstakes entry must be received no later than Sunday, January 19, 2025 at 11:59 p.m. LIMIT ONE (1) VALID ENTRY PER PERSON. Successful completion of the foregoing shall be considered an “Entry” and the person submitting the Entry, the “Entrant.” As a condition of entering the Sweepstakes, each entrant gives consent for Bay FC to obtain and deliver their name, address and other information to third parties for the purpose of administering this Sweepstakes and to comply with applicable laws, regulations and rules. Any information entrant provides to Bay FC may be used to communicate with entrant in relation to this Sweepstakes or on a Sweepstakes winner’s list.

4. LIMIT: one (1) entry per Entry. Multiple entrants are not permitted to share the same email address or account. Any attempt by any entrant to obtain more than the stated number of entries by using multiple/different email addresses, accounts, identities, registrations and logins, or any other methods will void that entrant’s entry and that entrant may be disqualified. Use of any automated system to participate is prohibited and will result in disqualification. In the event of a dispute as to the identity of any entry, the authorized account holder of the email address used to enter will be deemed to be the entrant and he/she must comply with these Official Rules. The “authorized account holder” is the natural person assigned an email address by an Internet access provider, online service provider or other organization responsible for assigning email addresses for the domain associated with the submitted address. Potential winners may be required to show proof of being the authorized account holder.

5. SELECTION OF WINNER: Three (3) winners will be randomly selected from all eligible Entries received within the Sweepstakes Period. The winner will be notified on or about Monday, January 20, 2025, through the email address provided by the selected winner on the Entry. Only the selected winner will be notified. The winner will be required to sign and return to Bay FC an affidavit of eligibility and liability and publicity release within 48 hours of receipt. If any prize notification is undeliverable, if the potential winner does not respond to notification in a timely manner, or in the event of non-compliance with any of these requirements, the prize will be forfeited,

and an alternate winner will be selected from the remaining eligible entries. The odds of winning depend on the number of eligible Entries received within the Sweepstakes period.

6. PRIZE and VALUES: One (1) prize will be awarded for the Sweepstakes (“**Prize**”). The Prize will consist of a piece of Bay FC merchandise autographed by a Bay FC player or Players. The Prize details and availability are subject to change and in the event that Bay FC is unable to provide the winner(s) with his or her Prize(s), Winner(s) will be solely responsible for all federal, state and/or local taxes, and for any other fees or costs associated with the Prize(s) they receive (including parking and transportation), regardless of whether they, in whole or in part, are used. The approximate retail value of each the Prize is \$200. The prize cannot be exchanged for cash and there are no substitutions. Transfer of the prize is prohibited. Bay FC reserves the right to substitute a similar prize of equal or greater value at its sole discretion. Limit of one (1) prize per person.

7. ODDS. Odds of winning will depend upon the total number of entries received.
